CRITERIA All styles from non-objective to abstracted realism are welcome. All works must be original, and have been created in the last five years. References used in the creation of the submitted work must be the artist's own, or copyright-released for use in this work. Works previously exhibited at The Art Guild Gallery will not be considered.

MEDIUMS: Including but not limited to acrylic, charcoal, collage, colored pencil, digital art, ink, oil, mixed media, pastel, pencil, photography, printmaking, sculpture or watercolor. No Copies, Master Copies, Reproductions OR Giclees.

JUDGE: Alex Ferrone has resided on the North Fork for sixteen years and has many ties to the East End community from her twenty years of aerial photography clientele, to contacts through a number of East End organizations for which she has volunteered. Her artistic and business organization memberships have included National Association of Women Artists, East End Photographers Group, Long Island Wine Council, Discover Long Island, East End Arts, North Fork Promotion Council, East End Women's Network, and the Mattituck, Riverhead, and North Fork Chambers of Commerce.

A fine art photographer herself, Ferrone has presented her works in numerous national gallery and museum exhibits and internationally in Italy and Spain. Her work has been featured on TV and has been published in magazines and periodicals nationally and internationally including Wine Spectator, Vanity Fair Magazine, The Wall Street Journal, The New York Times, and the Robb Report. SIZE and FRAMING Frame size must not exceed **30"** on the longest side and wired securely for hanging with screw eyes or D-rings to the frame, NOT the backboard. No sawtooth hangers, tape or string. Work must be labeled with the title, artist's name, street address, phone number, and email. Framing of your work must comply with the above OR IT WILL NOT BE ACCEPTED.

ENTRY FEE Registration is required and fees are non-refundable.

AWARDS 1st Place \$300 • 2nd Place \$200 • 3rd Place \$100 and Honorable Mentions.

SALES Artwork may be sold directly by the artist with a suggested donation of 20% of the selling price from the artist to The Art Guild.

LIABILITY and INSURANCE The Liability Waiver on the entry form must be signed by the artist submitting images for consideration. It is the responsibility of the participating artist to insure or self-insure any work submitted for inclusion in this exhibit.
