

### 2022 Call for Photographers: Into the Light

As we emerge from a darker time we hope to see the world around us in a new light. Some of us have traveled while others have found new joys at home. Whether in color or in black and white, this show encourages the use of light to engage the viewer in a story of brighter visions.



**CRITERIA** All photographic genre are welcome: portraits, landscapes, photojournalism, and macro photography. Composite photography is accepted as long as the elements in the final image are the work of the photographer. All work must be original. Submitted work must be the artist's own. Works previously exhibited at The Art Guild will not be considered.

**JUROR** John Bruno became interested in photography during a tour of duty with the U.S. Air Force in Spain. Using a simple fixed focal length 35mm rangefinder camera he documented his travels in Europe and became hopelessly hooked. He has worked with the NY Giants as a freelance photographer and was a member of Canon's "Professional Program". John's specialty is photographing performers and is currently the photographer for the Bronx Opera Company.

#### Into the Light - February 13 - March 5, 2022

**SIZE and FRAMING** Frame size must not exceed 36" on the longest side and wired securely for hanging with screw eyes or D-rings to the frame, NOT the backboard. No sawtooth hangers, tape, string, or gallery wraps. Work must be labeled with the title, artist's name, street address, phone number, and email. Framing of your work must comply with the above OR IT WILL NOT BE ACCEPTED.

#### ENTRY FEE Registration is required and fees are non-refundable.

**FINALISTS** The Selection Committee will review all entries and notify each artist as to the acceptance of the submitted work. The Art Guild has the right, in its sole discretion, to choose which eligible entries will be accepted to be exhibited. All decisions are final. **Artists whose work has been selected will be notified after February 1,** either by email OR on our website.

**AWARDS** 1st Place \$300 · 2nd Place \$200 · 3rd Place \$100 and Honorable Mentions. Student awards will also be given, if appropriate.

**SALES** Artwork may be sold directly by the artist with a suggested donation of 20% of the selling price from the artist to The Art Guild.

**LIABILITY and INSURANCE** The Liability Waiver on the entry form must be signed by the artist submitting images for consideration. It is the responsibility of the participating artist to insure or self-insure any work submitted for inclusion in this exhibit.
